BEACHNER GRAIN, INC., CREDIT AGREEMENT

KANSAS CONTRACT: This contract is entered into in the State of Kansas and shall be construed according to the laws of the State of Kansas, and it is agreed that the sole forum for any litigation arising out of this contract shall be the County of Neosho, State of Kansas.

ACCEPTANCE OF TERMS OF CONTRACT: Receipt of this agreement by buyer shall be the acceptance of same, according to the terms thereof.

TOTAL AGREEMENT: This contract, and terms and conditions set forth herein, represents the entire agreement between the parties hereto.

DUE DATE: All purchases on credit during the month that are reflected on the period billing statement for such month are due and payable upon receipt of the billing statement, or as disclosed on the billing statement, if different.

CONVENIENCE CREDIT: If all credit purchases on the customers' statement are paid in full before the 15<sup>th</sup> day of the month following the month of purchase, the account shall not be subject to a FINANCE CHARGE.

FINANCE CHARGE: Any account balance not paid by the 15<sup>th</sup> of the month shall be subject to a FINANCE CHARGE of 1.5% per month, which is an ANNUAL PERCENTAGE RATE of 18% on the outstanding balance. The minimum amount of such charge shall be \$2.00 per month.

TERMINATION OF CREDIT: An account or any portion of an account that is past due will be considered delinquent, and as a result, credit privileges may be terminated. Beachner Grain, Inc., reserves the right to terminate credit sales to a customer at any time without prior notification.

COLLECTION: Beachner Grain, Inc., can recover reasonable COSTS, collection costs or attorney fees (but not both) at a rate not to exceed 15% of the unpaid debt after default. All past due accounts will become subject to these collection costs.

CHANGE IN TERMS: This agreement may be changed by Beachner Grain, Inc., within the limitations of applicable law. Notice of any changes shall be given prior to the effective date of change.

AGENCY: Until notified in writing to the contrary, Beachner Grain, Inc., may assume that customer's spouse, children and employees, are authorized to purchase goods and services for the customer's account.
